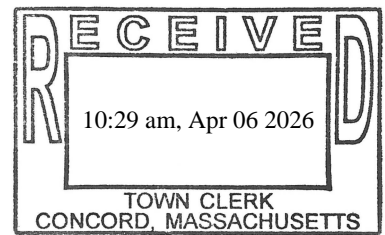

**New Public Hearings:**

7:00 p.m. – Holly Salemy, (Applicant) on behalf of Concord Museum, (Owner) for a Special Permit under Zoning Bylaw Sections 5.4.5 and 11.6 to hold a one-day, outdoor event at **53 Cambridge Turnpike** (Parcel #0109).

7:05 p.m. – Johanna Boynton, (Applicant/Owner) for a Special Permit under Zoning Bylaw Sections 7.1.5 and 11.6 to relocate and attach an existing garage and construct a 2,926 sq. ft. two-story addition to the single-family dwelling that extends the nonconforming side yard setback and increases the gross floor area by more than 50% at **83 Monument Street** (Parcel #1288).
